\*\* The Board anticipates convening in executive session pursuant to section 92-5(a)(2), HRS to consider the evaluation of its executive director where considerations of matters affecting privacy will be involved.

The meeting will held in accordance with Governor Ige's Emergency Proclamation for COVID-19, Supplementary Emergency Proclamation for COVID-19 and the Second through Twenty-First Proclamation, Emergency Proclamation Related to Sunshine Law In Person Meetings dated December 29, 2021 and Governor Ige's Executive Order 21-08 related to the COVID-19 Emergency. As such, each visitor shall provide verification of being fully vaccinated or, if not fully vaccinated, shall produce a negative test result of a COVID-19 test within the past 72 hours as a condition to being allowed to enter Hale Iako. When testifying, you will be asked to identify yourself and the organization, if any, that you represent.
