# Item 7. Financial Report

#### **Financial Report Summary**

July 2024 through May 2025

Data for the month of June was not available to show the full fiscal year 2025 finances. The report below reflects the first 11 months of the FY2025. There are no significant differences in the trends noted at the last Board meeting in May 2025.

#### FY 2025 Revenue vs. FY 2024 Revenue: (See Appendix A for Details)

- Total revenue for the first ten months of FY25 was approximately \$4,798,000. This
  reflects a 4.1% increase over the same period last year. Of notice for FY25 are the
  following:
  - Overall, seawater system revenue is up by approximately \$65,100 or 4.8%. This is mainly due to an increase in deep sea water usage by Captura and Makai Ocean Engineering in the makai campus.
  - HOST Park land rent is relatively flat compared to the same period FY24.
  - Research Campus outdoor space revenue increase by approximately \$58,000 (or 29.7%), mostly due to increased outdoor space rentals along with a small increase in office space revenue. Some office vacancy, however, is expected starting July1, 2025.
  - Percent rent reports were due by end of March and % rent revenue received was approximately \$47,000, an increase of 36.8% over last year.
  - Labor services remained lower than last year by approximately \$44,500 or 42.3% less than the same period last year. The bulk of this difference comes from a reduction in work requested by the Department of Health (a Kona coast water quality special study ended and a regular sampling project from Kauai has been on hold due to staffing shortages by DOH).
  - Electric reimbursements were somewhat stable but freshwater reimbursements were up by 22.6%.
  - Miscellaneous income is up 19.4% (or approximately \$49,400) compared to the same period last year. Late fees constitute the bulk of this increase.

#### FY 2025 Expenditure vs. FY 2024 Expenditure: (See Appendix B for details)

• Total expenses for the first ten months of fiscal year 2024 were approximately \$4,583,000, a 0.05% increase from last fiscal year. We continue to monitor expenditures very closely. Of note are the following:

- Seawater system expenditures were up by approximately \$89,200 or 7.1%.
   Personnel costs were significantly lower than the same period last year due to vacancies, which have since been filled. But costs related to higher water usage such as electricity contributed to the higher sweater system expenses.
- Total tenant utilities increased by 4.1% mostly due to higher freshwater usage.
- NELHA electrical usage increased by 33.8%. this was in part caused by the
  replacement of a faulty meter and in part to accommodate large water usage by
  several clients in the makai research campus. This was offset by less freshwater use
  so that total NELHA utilities increase was about 21.9%.
- HOST Park ground maintenance and monitoring decreased due to reduced personnel costs under the operations group as well as decreased purchase of supplies. Limited operations staff time has instead been diverted to the maintenance of the beach park.
- Environmental monitoring expenses increased by 6.8% primarily because services have been engaged to address water quality concerns by hatcheries.
- Beach Park Maintenance increased by 30.2% as usage of the beach park continues to be high and requires increasing amounts of supplies and attention from our operations department.
- Administrative expenses increased by approximately \$174,600 (11.3%). This is large
  part due to increased personnel costs in part due to union mandated salary
  increases and due to the full payment of hazard pay to all non UPW staff (UPW staff
  received their hazard pay in July 2025). Other areas with increased expenditures
  were repair and maintenance on buildings, solid waste removal and contract
  services. These are offset by other admin expense areas decreases.

#### Special Fund Account Summary (See Appendix C for details)

Special fund balance is at \$785,488.54, a modest increase from the last report
presented to the Board in May which was \$776,716.99. The larger encumbrances for the
1-year security services and Kau pipeline removal contracts are reflected in the
numbers.

#### Arrears Report: (See Appendix D for details)


• As of May 31, 2025, the arrears were \$84,263.03. These are listed in Appendix D and staff is addressing by working with the specific companies and situations.

## Special Fund Revenue FY 20-FY 25


